As we look back and reflect on 2023, we were able to see growth in so many different ways. Discipleship and baptisms increased. Our programs grew and we served over 520 students. Our staff grew as we employed 48 staff and 14 student-interns. Our housing program more than doubled as we flipped homes and saw six families go from renters to homeowners. Skating at the Frozen Sandlot saw its 2nd biggest year. Including our Bridges Homes program, Bridges nearly reached a million dollar budget. In many ways we have grown, but ultimately not much has changed either. Our main focus is to listen to God, obey Christ and His commands and share His love with others. He is in charge!
