2022 Annual Report

Last year's annual report talked about how much it reminded us of our very first year in Bridges. There were so many changes, moving parts and steps of faith. Well, this year started to feel much more similar to years past. In a good way, we were able to build up our programs after COVID, create a strong experienced team of staff and add some new projects. 2021 was the planting year so that 2022 could be the growth year. Both were fruitful in their own way, but 2022 allowed us to find some rhythms that strengthened our ministry! As we progress through our mission of Bridging people to Christ and making disciples that make disciples we are starting to see a larger group in our community. God has been so faithful to Bridges, our community has been faithful to Bridges and we are so proud to be a part of this faithful community!

By the Numbers- 2022 Highlights:

- We saw 5 students baptized and more than double that amount disciplined.
- Bridges Homes flipped and sold 3 homes; Turning renters into homeowners!
- Project 30, our mentoring program, grew to over 80+ students being actively mentored.
- We hired two new full-time staff. Currently two of our four directors are past Bridges students!
- Over 5,800 people came out and skated at the Frozen Sandlot. We started a new internship program as well and employed 32 staff/interns this year at the ice rink!
- Bridges after-school programs doubled in size and our Christmas party was back to pre-covid numbers. Nearly 400 students were served through Bridges this year.
- Bridges To College went on 3 college visits and numerous trips around the State of Indiana!
